# COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and in response to Order No. 8, files this Recommendation on Administrative Completeness and Proposed Procedural Schedule. Staff recommends that the application be deemed administratively complete. In support thereof, Staff shows the following:

#### I. BACKGROUND

On February 25, 2019, Undine Texas, LLC (Undine) and Texas Water Systems, Inc. (TWS) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Gregg, Henderson, Limestone, Smith, and Upshur Counties, Texas. On March 11, 2019, Applicants filed an amended application. Specifically, Undine seeks approval to acquire facilities and to transfer a portion of water service area currently owned by TWS under Certificate of Convenience and Necessity (CCN) No. 12473. The requested transfer includes approximately 6,478 acres and 997 current customers.

On October 29, 2019, Order No. 8 was issued, establishing a deadline of January 23, 2020 for Staff to file a recommendation on the administrative completeness of the application and notice and propose a procedural schedule for further processing of the application. Therefore, this pleading is timely filed.

#### II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum of Greg Charles in the Commission's Infrastructure Division, Staff has reviewed the application and recommends that the application be found administratively complete.

#### III. NOTICE

The Commission's notice requirement for sale, transfer, merger applications are provided by 16 Texas Administrative Code (TAC) § 24.239. Specifically, Staff recommends that Applicants be ordered to provide notice according to the attached memorandum of Mr. Charles.

#### IV. MOTION TO RESTYLE DOCKET AND COMMENTS ON STYLING

This docket is currently styled as the "Application of Texas Water Systems, Inc. and Undine Texas, LLC for Sale, Transfer, or Merger of Facilities and Certificate Rights in Gregg, Henderson, Limestone, Smith, and Upshur Counties." While reviewing the application, Staff has reached the conclusion that this styling is not accurate with regard to the counties listed in the styling. Staff proposes that this docket be restyled as the "Application of Texas Water Systems, Inc. and Undine Texas, LLC for Sale, Transfer, or Merger of Facilities and Certificate Rights in Gregg, Henderson, Smith, Upshur, and Van Zandt Counties."

Additionally, the Application, as amended, seeks to accomplish more than just acquiring facilities and transferring a portion of water service area from Texas Water Systems under CCN No. 12473 to Undine's CCN No. 13260 in this docket. With the amended application, the Applicants also seek to add uncertificated service areas, to decertify some areas from CCN No. 12473, and to obtain dual certification with a portion of Crystal Systems Texas, Inc.'s water CCN No. 10804, and obtain dual certification with a portion of Pritchett WSC's water CCN No. 10478. Staff raises these issues with ALJ, in the event that the ALJ should choose to exercise his discretion as to whether this docket should also be restyled to explicitly indicate these other elements of the amended application.

#### V. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

On February 25, 2019, Undine Texas, LLC (Undine or Buyer) and the Texas Water Systems, Inc., (Texas Water Systems or Seller), (collectively, Applicants), filed an application for Sale, Transfer, or Merger (STM) of facilities and certificate rights in Gregg, Henderson, Limestone, Smith and Upshur Counties, Texas, pursuant to Texas Water Code Ann. (TWC) § 13.301 and the 16 Texas Administrative Code (TAC) § 24.239.

On March 11, August 1, August 8, September 13, 2019, Applicants filed amendments and supplemental documents to the application. On December 3 and December 6, 2019, in response to Corrected Order No. 8, the Applicants provided explanations for the need for service. Specifically, the Buyer seeks approval to acquire facilities and to transfer all of the water service area from Texas Water Systems under Certificate of Convenience and Necessity (CCN) No. 12473 to Undine's CCN No. 13260. In addition, Undine seeks to add uncertificated areas, to decertify portions of CCN No. 12473, and to obtain dual certification with a portion of Crystal Systems Texas, Inc's water CCN No. 10804, and to obtain dual certification with a portion of Pritchett Water Supply Corporation's water CCN No. 10478.

Staff notes that the current style of this docket considers only a portion of the application regarding the Applicants' STM application, not the request to add uncertificated area, and the request for decertification of a portion of the Seller's CCN area, and for dual certification with portions of other certificated entities. Staff also request the restyle to include the correct county names, Gregg, Henderson, Smith, Upshur, and Van Zandt counties. Consequently, Staff requests that the style of the docket be changed to "Application of Texas Water Systems, Inc. and Undine Texas, LLC for Sale, Transfer, or Merger of Water Facilities and Certificate Rights, to add uncertificated areas, to Decertify a Portion of Texas Water Systems, Inc.'s Certificated area, to Obtain Dual Certification with a Portion of Crystal Systems Texas, Inc.'s Certificated Area, and to Obtain Dual Certification with a Portion of Pritchett Water Supply Corporation in Gregg, Henderson, Smith, Upshur, and Van Zandt Counties."

Based on Staff's review of the application and supplemental documentation filed by the Applicants, Staff found that it is sufficient in the required application and mapping information. Therefore, Staff recommends that the application be deemed sufficient for filing and found administratively complete. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide notice of the application to the following:
  - a) Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
  - b) The county judge of each county that is wholly or partially included in the requested area;

- c) Each groundwater conservation district that is wholly or partially included in the requested area:
- d) Landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the requested area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the requested area is located;
- e) Any affected customers, and other affected parties in the requested area; and
- f) Publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Gregg, Henderson, Smith, Upshur, and Van Zandt Counties.

Please note, Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed Staff may send requests for information (RFI) to the Applicant(s). The Applicant(s) will have 20 days from the receipt of the RFI to respond unless additional time is requested by the Applicant(s).

The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision:

Cape Tranquility, Country Club Estates, Friendship, Garden Acres, Garden Valley Resort, Mount Sylvan, Rosewood & Harmony, Stallion Lake Ranch, and Camp Joy.

A portion of the requested area overlaps the district boundaries of the Sabine River Authority and the Upper Sabine Valley Solid Waste Management District. If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large scale map and a metes and bounds description of the landowner's tract of land.

All opt out requests must include a large scale map and a metes and bounds description of the landowner's tract of land.
