FEBRUARY 2021 STATUS REPORT & REQUEST FOR EXTENSION

COMES NOW Undine Texas, LLC ("Undine") and files this February 2021 Status Report in response to Order No. 14. Order No. 14 granted Undine request for extension and set a deadline of March 28, 2021 to complete the transaction.

Undine hereby reports that despite the diligent efforts of Undine and Texas Water Systems, Inc. ("Texas Water") to close the transaction in advance of the March 28, 2021 deadline, the parties have found that the circumstances that precipitated the previous request for extension have continued to delay the closing of the transaction.


Undine hereby requests a ninety (90)-day extension to the March 28, 2021 deadline, to June 28, 2021, to close the transaction. Undine represents that this request is not being made for the purpose of delay, but in order to properly conclude all of the actions prerequisite to closing the transaction.
