COMES NOW Undine Texas, LLC ("Undine") and files this April 2021 Status Report and Request for Extension in response to Order No. 15. Order No. 15 granted Undine's request for extension and set a deadline of June 28, 2021 to complete the transaction.


Undine hereby reports that despite the diligent efforts of Undine and Texas Water Systems, Inc. to close the transaction in advance of the June 28, 2021 deadline, the parties have found that the circumstances that precipitated the previous request for extension have continued to delay the closing of the transaction.

Undine hereby requests a ninety (90)-day extension to the June 28, 2021 deadline, to September 26, 2021, to close the transaction. Undine represents that this request is not being made for the purpose of delay, but in order to properly conclude all of the actions prerequisite to closing the transaction. Undine is prepared to submit further information in support of this request at the request of the Administrative Law Judge.

The undersigned has consulted with John Harrison, counsel for Commission Staff, who has stated he has no objection to this request.
