**SOAH ORDER NO. 3
MODIFYING PROCEDURAL SCHEDULE,
RESETTING AND CONVERTING TO TELEPHONIC HEARING ON THE MERITS,
AND REQUIRING PARTIES TO CONFER**

On April 20, 2020, the Staff of the Public Utility Commission (Staff) filed a Joint Proposed Amended Procedural Schedule. The filing indicates that Michael E. Moore (Moore) and C Willow Water Company (C Willow) agree to the amended proposed procedural schedule.

The procedural schedule is **MODIFIED** as set forth below:

PLEASE NOTE that the hearing has been set for a **TELEPHONIC** hearing on the merits. In response to the emergency declarations relating to COVID-19, the State Office of Administrative Hearings (SOAH) has temporarily discontinued all non-emergency live, in-person hearings. Accordingly, this proceeding is being converted to a telephonic hearing.

It is therefore **ORDERED** that the Administrative Law Judge (ALJ) will convene a **telephonic hearing at 9:00 a.m. on June 23, 2020**. The ALJ will use a conference bridge for the hearing. At the time of the hearing, parties should call the dial-in number and, at the prompt, enter the conference ID number followed by the # sign.

If you wish to have an in-person hearing, you must file a written request to reschedule the hearing. The hearing will be rescheduled for a later date and time, after COVID-19 emergency orders have been lifted and when live, in-person hearings have resumed at the State Office of Administrative Hearings.

It is further **ORDERED** that the following prehearing instructions shall be followed:

- **Prefiled Exhibits.** By **June 17, 2020**, the parties shall prefile all exhibits they intend to offer at the hearing on the merits, and provide the exhibits to the other party.
- **Witness Identification.** **June 17, 2020**, the parties shall file a witness list with the names and phone numbers for the witnesses they intend to call to testify during the hearing.
- **Witness Preparation.** Prior to the hearing, the parties must provide to witnesses all documents necessary for their effective participation in the hearing. Parties should also speak to the witnesses they intend to call to testify and advise them to expect a call from an unfamiliar number, and explain that they may be prompted by an automated system to join the conference call through which the hearing is being conducted.
