JOINT PROPOSED AMENDED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Joint Proposed Amended Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2019, Michael E. Moore (Moore) filed a complaint against Shady Oaks Water, L.P. dba C-Willow Water Company (C-Willow) regarding water billing and related charges. The complaint was filed pursuant to 16 Texas Administrative Code (TAC) § 22.242. On March 19, 2019, C-Willow filed its response to the complaint.

On April 24, 2020, State Office of Administrative Hearings (SOAH) Order No. 3 was issued memorializing the amended procedural schedule agreed upon by all parties.

II. PROPOSED PROCEDURAL SCHEDULE

Staff has discussed with the parties and both have agreed to waive objections to rebuttal testimony and replies to objections to rebuttal testimony in the interest of keeping the Hearing on the Merits on June 23, 2020. Thus, Staff proposes, and Moore and C-Willow join in agreement to, the following joint amended proposed procedural schedule for the processing of this docket:
