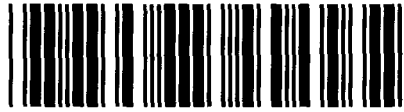

**COMMISSION STAFF'S REQUEST FOR EXTENSION**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension, and would show the following:

**I. BACKGROUND**

On February 26, 2019, Michael E. Moore (Complainant) filed a complaint against C Willow Water Company (C Willow) regarding water billing and related charges. The complaint was filed pursuant to 16 Texas Administrative Code (TAC) § 22.242. On March 19, 2019, C Willow filed its response to the complaint.

On March 29, 2019, the Commission administrative law judge (ALJ) issued Order No. 2, which required Staff to file a supplemental statement of position by May 1, 2019. Therefore, this pleading is timely filed.

**II. STAFF'S REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review and analyze the response to Staff's RFI that the C Willow filed on April 26, 2019 and respectfully requests that the Administrative Law Judge extend the deadline for filing Staff's supplemental recommendation to May 8, 2019. Upon conferring with Staff, Complainant and C Willow advise that they do not object to the extension.

**III. CONCLUSION**

For the reasons discussed above, Staff respectfully requests the entry of an order consistent with the above recommendation.


