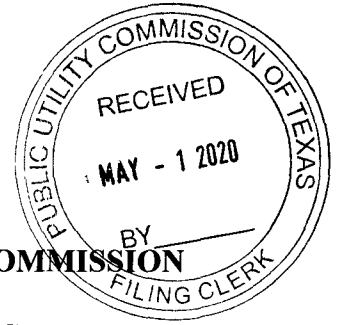

**COMMISSION STAFF’S REQUEST FOR EXTENSION**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

**I. BACKGROUND**

On February 26, 2019, the City of Floresville (Floresville) filed an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20279, in Wilson County, Texas. The requested area includes approximately 4,201 acres and 171 connections.

On May 31, 2019, the Commission administrative law judge (ALJ) issued Order No. 3, finding the application administratively complete and requiring notice. On April 9, 2020, the ALJ issued Order No. 12, finding Floresville’s notice sufficient.

Order No. 12 directed Staff to provide final maps, certificates, and tariffs to Floresville for review and consent by May 4, 2020. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Floresville has not yet addressed a landowner’s opt-out request, filed on November 20, 2019, or filed revised mapping information with the Commission as required by 16 Texas Administrative Code (TAC) § 24.227(h)(2). Consequently, Floresville will need additional time to provide revised mapping information to address the landowner’s opt-out request, and Staff will need time to review the revised mapping information. As such, Staff requests that Floresville be required to file revised mapping information by May 26, 2020, and that the remainder of the procedural schedule be amended, as requested below:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	June 25, 2020
Deadline for Applicant to file signed consent forms with the Commission	July 9, 2020
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	July 16, 2020
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	July 23, 2020

### III. CONCLUSION

Staff respectfully requests the issuance of an order granting Staff's request, requiring Floresville to file revised mapping information by May 26, 2020, and amending the procedural schedule for further processing of this docket.
