COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS OF THE APPLICATION AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 2, files this Supplemental Recommendation on Administrative Completeness of the application and Proposed Procedural Schedule. Staff recommends that the application be found sufficient for further review. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2019, the City of Floresville (Floresville) filed an application to amend its sewer Certificate of Convenience and Necessity No. 20279, in Wilson County, Texas. The requested area includes approximately 4,201 acres and 171 connections.

On March 29, 2019, the Commission Administrative Law Judge (ALJ) issued Order No. 2, finding the application administratively incomplete and insufficient for further review, and requiring Floresville to file a supplement to cure the application of the deficiencies identified by Staff in the attached memorandum to its First Administrative Completeness Recommendation, by April 29, 2019. Floresville filed supplemental information on April 25th and May 10th of 2019.

Order No. 2 also directed Staff to file a supplemental recommendation on the administrative completeness of the application and to propose a procedural schedule for further processing of the application by May 29, 2019. Therefore, this pleading is timely filed.

II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum from Spencer English in the Commission's Water Utility Regulation Division, Staff has reviewed the application and supplemental

information filed by Floresville and recommends that it be found administratively complete and accepted for filing.

III. NOTICE

As detailed in the attached memorandum, Staff recommends that Floresville proceed with providing public notice. Specifically, Staff recommends that Floresville be directed to use the attached *Notice for Publication* form to publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Wilson County. Staff further recommends that Floresville be directed to use the attached *Notice to Landowners, Neighboring Systems, and Cities* form to complete the following actions:

- 1) Provide notice of the application to the following:
 - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
 - b) the county judge of each county that is wholly or partially included in the requested area;
 - c) each groundwater conservation district that is wholly or partially included in the requested area;
 - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the requested area to be certified; and
 - e) affected customers and other affected parties in the requested area.
- 2) Provide correct notice of the application to the following:
 - Evergreen UWCD
 - San Antonio River Authority
 - Wilson County FWSD 1 of Wilson County Texas
 - Wilson County Judge
- 3) Provide an accurate map delineating the requested service area with each individual notice to neighboring utilities, other affected parties, landowners, and customers.
- 4) File in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the

publisher's affidavit for proof of newspaper publication. It is recommended that Floresville use the attached notices and affidavits to meet these requirements.

IV. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

V. CONCLUSION

For the reasons detailed above, Staff recommends that the application, as supplemented, be found administratively complete, that Floresville be directed to provide notice as detailed above and in the attached memorandum, and that the procedural schedule proposed above be adopted.

On February 26, 2019, the City of Floresville (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20279 in Wilson County, Texas pursuant to Texas Water Code Ann. (TWC) §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

Staff has reviewed the additional information filed by the Applicant on April 25, 2019, and recommends that the application be deemed sufficient for filing and administratively complete. Staff further recommends the Applicants be ordered to do the following:

- 1) Provide notice of the application to the following:
 - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
 - b) the county judge of each county that is wholly or partially included in the requested area;
 - c) each groundwater conservation district that is wholly or partially included in the requested area; and
 - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the requested area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the requested area is located;
 - e) any affected customers, and other affected parties in the requested area; and
 - f) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Wilson County.
- 2) Provide correct notice of the application to the following:
 - Evergreen UWCD
 - San Antonio River Authority
 - Wilson County FWSD 1 of Wilson County Texas
 - Wilson County Judge
- 3) Provide an accurate map delineating the requested area with each individual notice to neighboring utilities, other affected parties, landowners and customers. Information related to

districts including addresses can be obtained by the Applicant from the TCEQ's web site located at http://www14.tceq.texas.gov/iwud/

4) File in the docket an affidavit specifying every person and entity to whom notice was provided and the date that the notice was provided and the publisher's affidavit for proof of newspaper publication. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.

Please note, Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed Staff may send requests for information (RFI) to the Applicants. The Applicants will have 20 days from the receipt of the RFI to respond unless additional time is requested by the Applicants.


