APPLICATION OF THE CITY OF FLORESVILLE TO AMEND A WATER CERTIFICATE OF CONVENIENCE AND NECESSITY IN WILSON COUNTY PUBLIC UTILITY COMMISSIONS

OF TEXAS

COMMISSION STAFF'S COMMENTS ON SUFFICIENCY OF REVISED MAPPING INFORMATION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files these Comments on the Sufficiency of the Revised Mapping Information. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2019, the City of Floresville (Floresville) filed an application to amend its water certificate of convenience and necessity (CCN) number 10688, in Wilson County, Texas. The requested area includes approximately 4,201 acres and 171 connections.

On December 14, 2020, the administrative law judge (ALJ) filed Order No. 19, requiring Staff to file comments on the sufficiency of the revised mapping information by December 29, 2020. Therefore, this pleading is timely filed.

II. COMMENTS

Staff has reviewed Floresville's first revised map, filed on November 12, 2020, and its third revised map, filed on December 11, 2020, and recommends that the revised mapping information be found sufficient. Floresville's first revised map, filed on November 12, 2020, depicts the proposed service area and locations of customers receiving or requesting service who are located outside Floresville's city limits, as required by Order No. 15. Floresville's third revised map, filed on December 11, 2020, depicts the boundaries of Floresville's city limits, the boundaries of Floresville's extraterritorial jurisdiction, and city, county, state, and federal roads, highways, and other similar routes, as required by Order No. 15. Analyzing the two revised maps together, Staff recommends that there is no need to revise its July 16, 2020 final recommendation and recommends that the application be approved.
