MOTION FOR AN AMENDED AGREED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Motion for an Amended Agreed Procedural Schedule and would show the following:

On February 28, 2019, the Yancey Water Supply Corporation (Yancey WSC) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11463, in Medina and Frio Counties, Texas. The requested area includes approximately 224,705 acres and 1,764 connections. On October 3, 2019, the Administrative Law Judge (ALJ) issued Order No. 7 establishing a procedural schedule in this docket for further processing. Staff needs additional time to review mapping issues related to this docket. As such, Staff proposes to amend the procedural schedule as follows:

Event	Deadline
Deadline for Intervention	August 2, 2019
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Yancey WSC for review and consent	December 2, 2019
Deadline for Yancey WSC to file signed consent forms with Commission	December 11, 2019
If no hearing is requested, deadline for Staff to file a final recommendation on the application	December 18, 2019
If no hearing is requested, deadline for parties to jointly file a proposed order containing detailed, legally sufficient findings of fact, conclusions of law, and ordering paragraphs	January 11, 2020

Yancey WSC, San Antonio Water System, and East Medina County Special Utility District
are unopposed to Staff's request for amended procedural schedule.
