MOTION FOR AN AMENDED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff) and Yancey Water Supply Corporation (Yancey WSC), representing the public interest and files this Joint Motion for an Amended Agreed Procedural Schedule and would show the following:

On February 28, 2019, Yancey WSC filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11463, in Medina and Frio Counties, Texas. The requested area includes approximately 224,705 acres and 1,764 connections. On November 25, 2019, the Administrative Law Judge (ALJ) issued Order No. 9, establishing a procedural schedule in this docket for further processing. Staff and Yancey WSC continues to need additional time to review mapping issues related to this docket. San Antonio Water System and East Medina County Special Utility District are agreeable to this motion. As such, Staff and Yancey WSC propose to amend the procedural schedule as follows:

Event	Deadline
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Yancey WSC for review and consent	March 13, 2020
Deadline for Yancey WSC to file signed consent forms with Commission	March 27, 2020
If no hearing is requested, deadline for Staff to file a final recommendation on the application	April 3, 2020
If no hearing is requested, deadline for parties to jointly file a proposed order containing detailed, legally sufficient findings of fact, conclusions of law, and ordering paragraphs	April 17, 2020
