JOINT MOTION FOR EXTENSION OF TIME

East Medina County Special Utility District (East Medina County SUD), San Antonio Water System (SAWS), Yancey Water Supply Corporation (Yancey WSC), and the Staff of the Public Utility Commission of Texas (PUC Staff)(cumulatively, Parties) file this request for extension and would respectfully show the following:

On April 1, 2020, the Honorable Administrative Law Judge issued Order No. 12 thereby establishing a June 17, 2020 deadline for the Parties to jointly file a proposed order containing detailed, legally sufficient findings of facts, conclusions of law, and ordering paragraphs. The Parties have conferred and are coordinating to jointly file a proposed order, but are respectfully requesting a one-week extension to finalize the proposed findings of fact, conclusions of law, and ordering paragraphs. This request is not sought for delay, but to afford all parties an opportunity to agree upon the detailed and legally sufficient findings, conclusions and ordering provisions required by Order No. 12, and so that justice will be served.
