COMMISSION STAFF'S SECOND SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED NOTICE

COMES NOW the Commission Staff of the Public Utility Commission of Texas (Commission), representing the public interest, and in response to Order No. 3 files this Commission Staff's Second Supplemental Recommendation on Administrative Completeness and Proposed Notice. Staff recommends that it be found administratively complete and accepted for filing. In support thereof, Staff shows the following:

I. BACKGROUND

On March 1, 2019, the City of Fort Worth (Fort Worth) filed an application for a sewer certificate of convenience and necessity in Tarrant, Denton, Wise and Parker Counties. The requested service area consists of 261,819 acres and currently has 600,851 customers. Fort Worth filed supplemental information on April 29, 2019 and June 21, 2019.

On May 30, 2019, the Administrative Law Judge issued Order No. 3, setting a deadline of July 31, 2019, for Staff to file supplemental comments on the administrative completeness of the application, the sufficiency of the proposed notice, and to propose a procedural schedule. This pleading is therefore timely filed.

II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum from Nabaraj Pokharel in the Commission's Water Utility Regulation Division, Staff has reviewed the application and supplemental information filed by Fort Worth and recommends that it be found administratively complete and accepted for filing. Staff's recommendation on administrative completeness is not a comment on the merits of the application, but only that it is complete for further processing.



III. NOTICE

As detailed in the attached memorandum, Staff recommends that Fort Worth proceed with providing public notice. Specifically, Staff recommends that Fort Worth be directed to use the attached *Notice for Publication* form to publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Tarrant, Denton, Wise and Parker Counties. Staff further recommends that Fort Worth be directed to use the attached *Notice to Landowners*, *Neighboring Systems, and Cities* form to complete the following actions:

- 1) Provide notice of the application to the following:
 - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
 - b) the county judge of each county that is wholly or partially included in the requested area;
 - c) each groundwater conservation district that is wholly or partially included in the requested area;
 - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the requested area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the requested area is located;
 - e) any affected customers, and other affected parties in the requested area; and
- 2) Provide correct notice of the application to the following:

- 4) Within 30 days of the date of the notice, file in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, the date

that the notice was provided, and the publisher's affidavit for proof of newspaper publication. It is recommended that Fort Worth use the attached notices and affidavits to meet these requirements.

IV. PROCEDURAL SCHEDULE

Staff recommends the application, as supplemented, be found administratively complete. Staff therefore proposes the following procedural schedule:

V. CONCLUSION

For the reasons detailed above, Staff recommends that the application, as supplemented, be found administratively complete, that Fort Worth be directed to provide notice as detailed above and in the attached memorandum, and that the procedural schedule proposed above be adopted.

On March 1, 2019, City of Fort Worth, (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to obtain a sewer Certificate of Convenience and Necessity (CCN) in Tarrant, Denton, Wise and Parker Counties, Texas pursuant to Texas Water Code Ann. (TWC) §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

On April 29, 2019, the Applicant filed sufficient revised maps and on June 21, 2019 filed sufficient revised digital data in response to Commission Orders No. 2 and 3. Commission's mapping staff also confirmed that the Applicant is requesting to obtain a sewer CCN located in Dallas, Denton, Parker Tarrant and Wise Counties. Staff has reviewed the information and recommends the application be deemed administratively complete and sufficient for filing. 
