The total requested area includes approximately 3,355 acres and <u>0</u> current customers.

Convenience and Necessity in Tarrant, Denton, Wise and Parker Counties

On March 1, 2019, City of Fort Worth, (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to obtain a sewer certificate of convenience and necessity (CCN) in Denton, Parker, Tarrant and Wise Counties, Texas under Texas Water Code Ann. §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

The Applicant amended its application on October 16, 2019. Specifically, the Applicant now requests a reduced sewer CCN service

area of approximately 26,812 acres, with no existing retail wastewater customer connections.

Staff has reviewed the amended application, the supplemental information filed on February 20, 2020, and the revised maps and digital data filed on May 19, 2020, and recommends that the application be deemed administratively complete and sufficient for filing. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
  - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:

Within 30 days of the date the notice was mailed, Applicant must file an affidavit specifying the notice that was provided to every person and entity to whom notice was provided and the date the notice was mailed.
- 3) Provide notice using the attached notice forms.

- 4) Provide a copy of map delineating the requested area with each individual notice to neighboring utilities, other affected parties, landowners and customers.
- 5) File in the docket a map and copy of notice along with the signed affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the publisher's affidavit for proof of newspaper publication.

# COMMISSION STAFF'S REVISED SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS, PROPOSED NOTICE, AND PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and in response to Order No. 13, files this Commission Staff's Revised Supplemental Recommendation on Administrative Completeness, Proposed Notice, and Proposed Procedural Schedule. Staff recommends that the application be deemed sufficient for further review. In support thereof, Staff shows the following:

### I. BACKGROUND

On March 1, 2019, the City of Fort Worth (Fort Worth) filed an application for a sewer certificate of convenience and necessity in Tarrant, Denton, Wise, and Parker Counties. On October 16, 2019, Fort Worth filed supplemental information, constituting a substantial amendment to its original application (Amended Application). The requested service area now consists of 26,812 acres and has 0 customers.

On June 22, 2020, the Administrative Law Judge issued Order No. 13, setting a deadline of July 24, 2020, for Staff to file supplemental comments on the administrative completeness of the Amended Application, the sufficiency of the proposed notice, and to propose a procedural schedule. On July 24, 2020, Staff filed its supplemental recommendation but inadvertently excluded a necessary attachment. That attachment is included here.

### II. RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum from Nabaraj Pokharel in the Commission's Water Utility Regulation Division, Staff has reviewed the Amended Application, including the Applicant's supplemental information, and recommends that it be found administratively complete.

### III. RECOMMENDATION ON NOTICE

The Commission's notice requirements for certificate of convenience and necessity applications are provided by 16 Texas Administrative Code (TAC) § 24.235. At this time, Staff recommends that Fort Worth proceed with providing public notice to all persons, political subdivisions, and other entities listed in the attached memorandum using the notices provided by Staff. Along with each individual notice, Staff recommends that Fort Worth provide an accurate map delineating the requested service area. Staff also recommends that Fort Worth publish notice once each week for two consecutive weeks in a newspaper of general circulation in Denton, Wise, and Parker Counties. Within 30 days of the provision of notice, Staff recommends that Fort Worth file proof of notice and proof of newspaper publication as described in the attached memorandum. Finally, it is recommended that Fort Worth use the attached affidavits to meet these requirements

### IV. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:
