DEFINITIONS

- Staff 1-2 Please provide a map that shows the location of the customers receiving service identified by parcel in the requested areas. Also, include the current and proposed CCN boundaries. Please show the roads in a different color than the outer boundary of the parcel boundaries.
- Staff 1-3 Please provide the parcel acreage held by the current customer connections in the requested areas. For this portion of the requested area please also provide the total acreages for the following:
 - a. Acreage inside city limits
 - b. Acreage inside ETJ
 - c. Acreage outside the city limits and ETJ
- Staff 1-4 Please provide the parcel acreage held by landowners requesting service in the requested areas. For this portion of the requested area please also provide the total acreages for the following:
 - a. Acreage inside city limits
 - b. Acreage inside ETJ
 - c. Acreage outside the city limits and ETJ
- Staff 1-5 Please provide the parcel acreage where there are no requests for service and no current customers. For this portion of the requested area please also provide the total acreages for the following:
 - a. Acreage inside city limits
 - b. Acreage inside ETJ
 - c. Acreage outside the city limits and ETJ
- Staff 1-6 Please provide a map showing the facility lines within the requested area and along with the requested area, the current city limit and ETJ boundaries that includes the locations of current customer connections and requests for service in the requested area.
- Staff 1-7 Please provide a map showing the boundaries of the requested area, and the current city limit and ETJ boundaries. Also provide the connection count and acreage (by parcel) for each of the following:
