**COMMISSION STAFF’S NOTICE OF NO INTENT TO FILE AN AMENDED FINAL RECOMMENDATION**

Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, respectfully files this Notice of No Intent to File an Amended Final Recommendation. In support thereof, Staff shows the following:

On March 1, 2019, the City of Fort Worth (Fort Worth) filed an application for a sewer certificate of convenience and necessity in Tarrant, Denton, Wise, and Parker Counties. On October 16, 2019, Fort Worth filed supplemental information, constituting a substantial amendment to its original application, resulting in a requested service area that consists of 25,452 acres, with no customers and no requests for service. On January 8, 2021, Staff filed its final recommendation, in which it recommended the application not be approved at that time due to a lack of information showing need for service in the requested area.

On April 16, 2021, the administrative law judge (ALJ) filed Order No. 23, establishing a deadline for Staff to file an amended final recommendation by July 14, 2021. Therefore, this pleading is timely filed. Staff, however, does not intend to file any amendments to its final recommendation at this time.
