**CITY OF FORT WORTH'S
SECOND SUPPLEMENT TO APPLICATION**

COMES NOW, the City of Fort Worth, Texas (the "City"), by and through its undersigned attorneys of record, and files this Second Supplement to Application, and in support thereof, would show as follows:

I. BACKGROUND

On March 1, 2019, the City filed its application for a sewer Certificate of Convenience and Necessity ("CCN") in Tarrant, Denton, Wise, and Parker Counties (the "Application") with the Public Utility Commission of Texas (the "Commission"). On May 28, 2019, Commission Staff filed its Supplemental Recommendation on Administrative Completeness and Proposed Notice, recommending that the Application be deemed insufficient for further review and that the City be ordered to address certain mapping deficiencies identified in Commission Staff's May 23, 2019 memorandum. On May 30, 2019, the Administrative Law Judge issued Order No. 3 in this Docket, finding the Application insufficient, and requiring the City to cure the described mapping deficiencies by July 1, 2019. This pleading is therefore timely filed.

II. SUPPLEMENTAL INFORMATION TO THE APPLICATION

In response to Commission Staff's May 23, 2019 memorandum, the City supplements its Application with the following mapping information:


Additionally, in light of this revised digital data, the City now clarifies that the total acreage of the requested sewer CCN area is approximately 241.173 acres.

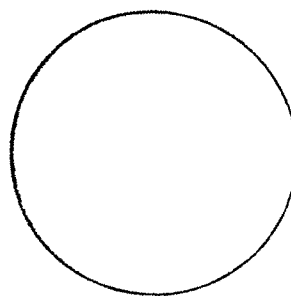
