#### **COMMISSION STAFF'S RECOMMENDATION ON FINAL DISPOSITION**

**COMES NOW** the Commission Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 6 files this, Commission Staff's Final Recommendation. In support thereof, Staff shows the following:

#### I. BACKGROUND

On March 1, 2019, Quadvest, LP, filed a petition on behalf of Previllage, LLC, to amend HMW Special Utility District's water Certificate of Convenience and Necessity No. 10342 in Harris County by expedited release, under Texas Water Code (TWC) § 13.254(a-5) and 16 Texas Administrative Code (TAC) § 24.245(1).

Order No. 6, issued September 18, 2019, set September 27, 2019, as the deadline for Staff to file its recommendation on final disposition. Staff filed its final recommendation on September 25, 2019.

#### II. STAFF'S CORRECTED FINAL RECOMMENDATION

Commission Staff's Final Recommendation filed on September 25, 2019 inadvertently omitted the Final Map and CCN certificate which were intended to be attached. The final map and CCN Certificate are attached to this filing.

#### III. CONCLUSION

For the reasons stated above, Staff respectfully recommends that the applicant's petition be approved.


