**COMMISSION STAFF'S AGREED MOTION FOR AN EXTENSION OF
TIME AND AMENDED PROCEDURAL SCHEDULE**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Agreed Motion for Extension of Time and Amended Procedural Schedule and would show the following:

On March 8, 2019, Park Water Company (Park WC) filed an application for water and sewer certificates of convenience and necessity in Midland County.

On July 22, 2019, the ALJ issued Order No. 5 setting forth a procedural schedule for further processing of the docket. Order No. 5 also required Staff to provide final maps, certificates, and tariffs (if applicable) to the applicants for review and consent by August 16, 2019.

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for the filing of any documents be extended for good cause. Staff requests extra time to review the tariffs, and Staff was informed that Park WC will be providing additional information to Staff. Accordingly, Staff moves for an extension of time to file its response to Order No. 5 and produce final maps, certificates, and tariffs (if applicable) until September 16, 2019.

Furthermore, Staff requests the procedural schedule to be amended as follows:

Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Park WC for review and consent	September 16, 2019
Deadline for Park WC to file signed consent forms with Commission	September 26, 2019
If no hearing is requested, deadline for Staff to file a final recommendation on the application	October 8, 2019
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law.	October 18, 2019

Park WC is in agreement with Staff's motion for extension of time and amended procedural schedule.
