**COMMISSION STAFF'S MOTION FOR EXTENSION**

COMES NOW the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Second Agreed Motion for Extension. Staff respectfully requests a second additional extension of its deadline to file final maps, certificates, and tariffs. In support thereof, Staff shows the following:

**I. BACKGROUND**

On March 8, 2019, Park Water Company (Park WC) filed an application for water and sewer certificates of convenience and necessity in Midland County. On August 20, 2019, the ALJ issued Order No. 6 requiring Staff to provide final maps, certificates, and tariffs (if applicable) to the applicants for review and consent.

**II. MOTION FOR EXTENSION**

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to provide Park WC with final maps, certificates, and tariffs (if applicable) for review and consent. On September 3, 2019, Staff served Park WC with a Second Request for Information (RFI). Staff requests that the date to provide final maps, certificates, and tariffs (if applicable) to the applicants be extended to until October 16, 2019 to provide final maps, certificates, and tariffs (if applicable) after review of the responses to the RFI. Staff respectfully requests that the ALJ find good cause to extend response to Order No. 6 until October 16, 2019.

### III PROPOSED PROCEDURAL SCHEDULE

Event	Deadline
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Park WC for review and consent	October 23, 2019
Deadline for Park WC to file signed consent forms with Commission	November 4, 2019
If no hearing is requested, deadline for Staff to file a final recommendation on the application	November 15, 2019
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law.	December 2, 2019




