**COMMISSION STAFF'S AGREED MOTION FOR AN EXTENSION OF  
TIME AND AMENDED PROCEDURAL SCHEDULE**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Agreed Motion for Extension of Time and Amended Procedural Schedule and would show the following:

On March 8, 2019, Park Water Company (Park WC) filed an application for water and sewer certificates of convenience and necessity in Midland County.

On September 17, 2019, the ALJ issued Order No. 7 setting forth a procedural schedule for further processing of the docket. Order No. 7 also required Staff to provide final maps, certificates, and tariffs (if applicable) to the applicants for review and consent by October 23, 2019.

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to review Request for Information (RFI) responses filed by Park WC on October 18, 2019. Also, the Staff expert assigned to this case is currently out of the office until November 6, 2019. Therefore, Staff requests an extension of time until November 13, 2019 to provide final maps, certificates, and tariffs (if applicable) to the applicants.

Furthermore, Staff requests the procedural schedule to be amended as follows:

<b>Event</b>	<b>Deadline</b>
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Park WC for review and consent	November 13, 2019
Deadline for Park WC to file signed consent forms with Commission	November 15, 2019
If no hearing is requested, deadline for Staff to file a final recommendation on the application	November 26, 2019
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law.	December 5, 2019

Park WC is in agreement with Staff's motion for extension of time and amended procedural schedule.
