COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this proposed procedural schedule pursuant to Order No. 4. In support thereof, Staff would show the following:

I. BACKGROUND

On March 11, 2019, Quadvest, L.P. (Quadvest) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11612 in Montgomery County, Texas. The requested area includes approximately 92 acres and currently has no customers.

Order No. 4, issued July 12, 2019, found the notice sufficient and gave Staff a deadline of July 26, 2019, to file a proposed procedural schedule. This pleading is therefore timely filed.

II. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Event	Date
Notice completed	June 19, 2019
Deadline for intervention	July 19, 2019 ¹
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	September 17, 2019
Deadline for Applicant to file signed consent forms with the Commission	October 1, 2019
If no hearing is requested, deadline for Staff to file final recommendation on the Application	October 8, 2019
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	October 23, 2019

¹ Pursuant to 16 TAC § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on June 5, 2019, and published on June 13 and 19, 2019. Therefore, 30 days after June 19, 2019 is July 19, 2019.


