APPLICATION OF QUADVEST, L.P. TO AMEND A WATER CERTIFICATE OF CONVENIENCE AND NECESSITY IN MONTGOMERY COUNTY

PUBLIC UTILITY COMMISSION OF TEXAS

QUADVEST, L.P.'S REQUEST FOR EXTENSION

COMES NOW, Quadvest, L.P. ("Quadvest") and files this Request for Extension. In support thereof, Quadvest shows the following:

I.

BACKGROUND

On March 11, 2019, Quadvest filed an application to amend its water Certificate of Convenience and Necessity No. 11612 in Montgomery County, Texas. On September 17, 2019, the Administrative Law Judge issued Order No. 6 establishing a procedural schedule that included a deadline of October 17, 2019 for Commission Staff to provide to the applicant final maps, certificates, and tariffs. Accordingly, this pleading is timely filed.

II.

QUADVEST'S REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Quadvest has been awaiting approval of the water utility distribution system from the Texas Commission on Environmental Quality ("TCEQ"), which Commission Staff requires in order to satisfy its October 17, 2019 deadline. TCEQ staff has indicated it will provide that approval no later than October 28, 2019. Accordingly, Quadvest requests that the dates set out in Order No. 6 be revised as follows:

Event	Date
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to the applicants for review and consent	November 1, 2019
Deadline for applicant to file signed consent forms with the Commission	November 18, 2019
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	December 2, 2019
If no hearing is requested, deadline for parties to jointly file detailed, legally sufficient findings of fact and conclusions of law	December 18, 2019

II.

CONCLUSION

For the reason stated above, Quadvest respectfully requests an extension of the deadlines set out in Order No. 6 as set forth above. The undersigned represents that he has discussed this filing with counsel for Commission Staff and that Commission Staff joins in this filing.
