**COMMISSION STAFF'S UNOPPOSED MOTION TO REVISE PROCEDURAL
SCHEDULE**

COMES NOW the Commission Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this, Commission Staff's Unopposed Motion to Revise Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On March 11, 2019, Quadvest, L.P., filed an application to amend its water Certificate of Convenience and Necessity No. 11612 in Montgomery County, Texas. The requested area includes approximately 92 acres and currently has no customers.

On October 18, 2019, the Administrative Law Judge issued Order No. 7, establishing a procedural schedule in which it was stated that Staff would provide to the applicant final maps, certificates, and tariffs by November 1, 2019. Therefore, this pleading is timely filed.

II. PROCEDURAL SCHEDULE

Staff and the applicants are in communication and applicants have obtained a permit from the Texas Commission on Environmental Quality. Additionally, Staff notes that the tariff for this matter is dependent upon the resolution of Quadvest's tariffs in Docket Nos. 48303, 49124, 49214, 49215, and 49216. Staff has conferred with Quadvest regarding this schedule, and is authorized to represent that Quadvest is unopposed to the adoption of the following revised schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	January 7, 2019
Deadline for Applicant to file signed consent forms with the Commission	January 14, 2019
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	February 6, 2020
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	February 17, 2020

III. CONCLUSION

For the reason stated above, Staff respectfully requests that an order be issued consistent with the foregoing.




