# ORDER NO. 4 REQUIRING PROOF OF NOTICE, GRANTING GOOD CAUSE WAIVER, AND AMENDED PROCEDURAL SCHEDULE

This Order addresses Commission Staff's request for good cause waiver and The Ridge at Frio River Water Company LLC's (The Ridge) requirements under Order No. 3.

# I. Second Requiring Proof of Notice to Customers

In Order No. 2, filed on April 17, 2019 the administrative law judge (ALJ) required The Ridge to file proof of the updated notice to customers by May 6, 2019. The Ridge failed to file proof of notice by that date. In Order No. 3, filed on May 24, 2019 the ALJ extended the deadline to file proof of the updated notice to customers to June 14, 2019. To date The Ridge has not filed proof of notice to customers. Under 16 TAC § 24.49(e), The Ridge is required to issue notice at least 30 days before the effective date of rate increase. The Ridge must provide by mail, or by electronic mail, if the ratepayer has agreed to receive communications electronically, the modified notice with the changed effective date and provide each ratepayer with the proposed rate adjustment. On or before July 24, 2019, The Ridge must file proof of the updated notice to customers. On or before August 7, 2019, Commission Staff must file comments on the sufficiency of the notice.

## II. Granting Good Cause Waiver

Under 16 Texas Administrative Code (TAC) § 24.49(f)(A) utilities with a certificate of convenience (CCN) number ending from 00-27 may file in Quarter 1 from January to March, and ending from 28-54 may file in Quarter 2 from April to June. The Ridge holds CCN No. 13233, ending in 33, and filed the application on March 14, 2019. Commission Staff request that The Ridge be granted a good cause exception to the required filing schedule. Commission Staff



acknowledged that The Ridge's application was not timely filed, but requested that the Quarter 2 filing requirement be waived. The ALJ grants the request and the requirement for The Ridge to file its price index adjustment applications in Quarter 2 is waived for this application.

### III. Amended Procedural Schedule

The administrative law judge amends the procedural schedule as following:
