**ORDER NO. 3
REQUIRING CLARIFICATION, REQUIRING PROOF OF NOTICE, AND
AMENDED PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation on administrative completeness and The Ridge at Frio River Water Company LLC's (The Ridge) requirements under Order No. 2.

I. Requiring Clarification

On April 15, 2019, Commission Staff filed a recommendation on administrative completeness. The memorandum of Spencer English attached to the recommendation states that the application was filed in the correct assigned month of March. Under 16 Texas Administrative Code (TAC) § 24.49(f)(A) utilities with a certificate of convenience (CCN) number ending from 00-27 may file in Quarter 1 from January to March. The Ridge holds CCN No. 13233, ending in 33. The administrative law judge (ALJ) requires Commission Staff to file a clarification on the correctness of the filing month on or before June 21, 2019.

II. Requiring Proof of Notice to Customers

In Order No. 2, filed on April 17, 2019 the ALJ required The Ridge to file proof of the updated notice to customers by May 6, 2019. To date The Ridge has not filed proof of notice to customers. Under 16 TAC § 24.49(e), The Ridge is required to issue notice at least 30 days before the effective date of rate increase. The Ridge must provide by mail, or by electronic mail, if the ratepayer has agreed to receive communications electronically, the modified notice with the changed effective date and provide each ratepayer with the proposed rate adjustment. On or before June 14, 2019, The Ridge must file proof of the updated notice to customers. On or before June 21, 2019, Commission Staff must file comments on the sufficiency of the notice.


III. Amended Procedural Schedule
