**ORDER NO. 5
FINDING NOTICE SUFFICIENT AND
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the sufficiency of the notice provided by Green Valley Special Utility District. On July 29, 2019, Green Valley SUD filed signed affidavits attesting that mailed notice was given to neighboring systems, landowners, customers and cities, along with a copy of the notice sent. On August 5, 2019, Green Valley SUD filed the publisher's affidavit attesting that published notice was given, and proof of newspaper publication notice.

The administrative law judge finds the notice sufficient and establishes the following procedural schedule:

Event	Date
Deadline to Intervene	September 13, 2019
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to the applicants for review and consent	October 9, 2019
Deadline for applicant to file signed consent forms with the Commission	October 23, 2019
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	October 30, 2019
If no hearing is requested, deadline for parties to jointly file detailed, legally sufficient findings of fact and conclusions of law	November 6, 2019
