

As noted in the Agreed Proposed Amended Procedural Schedule, the parties to this proceeding, Bear Creek Special Utility District, the Ratepayers of Bear Creek Special Utility District having brought this appeal, and Commission Staff (collectively, the “Parties”), have agreed on additional deadlines for propounding discovery on direct testimony, November 16, 2020, and for propounding discovery on rebuttal testimony, December 21, 2020. The Parties also recognize the January 21, 2021 deadline, set by the Administrative Law Judge, for prefiling exhibits and witness lists.¹

The Parties to this proceeding have conferred on the contents of this Agreed Proposed Amended Procedural Schedule and the Parties are in agreement.
