**ORDER NO. 1
REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE;
AND ESTABLISHING PROCEDURAL SCHEDULE**

I. Petition

This Order addresses the petition of Texas 903 Partners LP filed on March 20, 2019, requesting the expedited release of an approximately 320-acre tract of land within the boundaries of the City of Crandall's water certificate of convenience and necessity number 11295 in Kaufman County.

II. Requiring Comments on the Administrative Completeness

By April 22, 2019, Commission Staff must file comments regarding the administrative completeness of the petition and notice.

The City of Crandall or any other interested person must file a motion to intervene by April 22, 2019, in order to participate as a party in this proceeding.

III. Establishing Procedural Schedule

The following procedural schedule applies to this proceeding:

Commission Staff's comments on the administrative completeness of the petition and notice	April 22, 2019
Deadline for the City of Crandall and other affected persons to file a motion to intervene or comment on the petition	April 22, 2019

Additional deadlines will be established after the petition is deemed administratively complete.

IV. Filing Requirements

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission's filing clerk in accordance with 16 TAC § 22.71. A copy of each document filed with the Commission must also be served on all parties as required

by 16 TAC § 22.74. All filings can be accessed on the PUC Interchange webpage at, <http://interchange.puc.texas.gov>.

All parties will provide their current addresses, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, telephone, and fax information, if such information changes. The telephone and fax numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

V. Ex Parte Communications

Ex parte communications with the administrative law judge (ALJ) are prohibited under 16 TAC § 22.3(b)(2). Parties should communicate with the ALJ only through written documents filed with the Commission's filing clerk and served on all parties.
