COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 3, files this Supplemental Recommendation on Administrative Completeness and Proposed Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On March 27, 2019, Nerro Supply Investors, LLC (Nerro Investors) and Undine Texas, LLC (Undine) (collectively, Applicants), filed an application for the Sale, Transfer, or Merger of Facilities and Certificate Rights in Haris and Montgomery Counties, Texas. Specifically, the applicants seek to sell and transfer portions of Nerro Investors' facilities and service area under water Certificate of Convenience and Necessity (CCN) No. 10336 to Undine's CCN No. 13260. The requested transfer includes approximately 916 acres and 988 current customers.

On April 29, 2019, the Commission administrative law judge (ALJ) issued Order No. 2, finding the application deficient and requiring Applicants to file a supplement to cure deficiencies by May 28, 2019.

On May 28, 2019, Applicants filed a request for a 21-day extension to submit information intended to cure the identified deficiencies. On May 30, 2019, the Commission ALJ issued Order No. 3, granting Applicants request for an extension. On June 19, 2019, Applicants filed supplemental information to cure the application deficiencies.

Order No. 3 also required Staff to file a supplemental recommendation on the administrative completeness of the application and notice and to propose a procedural schedule for further processing of the application by July 18, 2019. Therefore, this pleading is timely filed.

II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum of Emily Sears in the Commission's Water Utility Regulation Division, Staff has reviewed the supplemental information filed by Applicants and recommends that the application, as supplemented, be found administratively complete.

III. NOTICE

The Commission's notice requirements for sale, transfer, merger applications are provided by 16 Texas Administrative Code (TAC) § 24.239. Specifically, Staff recommends that Applicants be ordered to provide notice as detailed in the attached memorandum of Emily Sears.

IV. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

Deadline for Staff to file a recommendation on sufficiency of notice	Within 10 days of the Applicants filing proof of completed notice with the Commission
Deadline for intervention; deadline for intervenors to request a hearing on the merits	30 days after notice is issued

V. CONCLUSION

For the reasons discussed above, Staff respectfully recommends that the application, as supplemented, be found administratively complete, that the Applicants be directed to provide notice as detailed above and in the attached memorandum, and that the procedural schedule proposed above be adopted for further processing of this docket.

On March 27, 2019, Nerro Supply Investors, LLC (Seller), and Undine Texas, LLC (Purchaser) (collectively, Applicants), filed an application for the Sale, Transfer, or Merger (STM) of facilities and certificate rights in Harris and Montgomery Counties, Texas, pursuant to Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239.

Specifically, Purchaser, under Certificate of Convenience and Necessity (CCN) No. 13260, seeks approval to acquire facilities and to transfer a portion of Seller's water CCN No. 10336. The requested area includes approximately 916 acres and 988 connections.

Based on Staff's review of the additional information filed by the Applicants on June 19, 2019, Staff recommends that the application and mapping information be deemed sufficient for filing and found administratively complete. Staff also recommends the following actions be required of Purchaser:

- 1) Provide notice of the application to the following:
 - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
 - b) the county judge of each county that is wholly or partially included in the requested area;
 - c) each groundwater conservation district that is wholly or partially included in the requested area; and
 - d) any affected customers, and other affected parties in the requested area.
- 2) Publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Harris and Montgomery Counties.
- 3) Provide correct notice of the application to the following entities:

- 5) Within 30 days of the date of notice, file in the docket a map and copy of notice, along with an affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the publisher's affidavit for proof of newspaper publication. It is recommended that Purchaser use the attached notices and affidavits to meet these requirements.
