The sale is scheduled to take place as approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: Hazy Hollow East Estates, Spring Creek Valley Estates, and Shady Brook Acres.

The requested areas subject to this transaction are located approximately:

Hazy Hollow East Estates

2.5 miles east/southeast of downtown Magnolia, Texas, and is generally bounded on the north by Little Thorn Lane and 260 feet north of Green Tree Road; on the east by Little Thorn Lane and Mildred Lane; on the south by Magnolia Boulevard/FM1774; and on the west by North Cripple Creek Drive. The total requested area for the water or sewer CCN(s) being transferred includes approximately 667 acres and 742 current customers.

Shady Brooks Acres

1.5 miles south of downtown Magnolia, TX, and is generally bounded on the north by Old Hockley Road; on the east by Nichols Sawmill Road; on the south by Country Place Road and Mink Branch; and on the west by Mink Branch. The requested area to be transferred includes approximately 95 total acres and 57 current customers.

Spring Creek Valley Estates

1.8 miles <u>northwest</u> of downtown <u>Tomball</u>, TX, and is generally bounded on the north by <u>Spring Creek</u>; on the east by <u>Parkplace Drive</u>; on the south by <u>Brown Road</u>; and on the west by <u>Spring Creek Park</u>. The requested area to be transferred includes approximately <u>154</u> total acres and <u>189</u> current customers.

This transaction will not have an effect on the current customer's rates and services.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is 30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer. You must send a letter requesting intervention to the commission which is received by that date.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
