APPLICANTS' SUBMITTAL OF DIGITAL MAPPING DATA AND DEANVILLE WSC DECERTIFICATION AGREEMENT

COMES NOW Undine Texas, LLC ("Undine") and files this Submittal of Digital Mapping Data and Deanville Water Supply Corporation ("Deanville WSC") Decertification Agreement, stating as follows:

On March 27, 2019, Applicant filed its Application for Sale, Transfer, or Merger of Facilities in Brazoria, Burleson, Chambers, Montgomery, Robertson and Walker Counties and to Decertify a Portion of Nerro's Certificated Area in Burleson County (the "Application").

The Whispering Woods Subdivision identified in the Application is located within a portion of the Deanville WSC service area under its Certificate of Convenience No. 10177. Attached as Exhibit A is the signed decertification agreement between Deanville WSC and Undine confirming Deanville WSC's agreement to decertify that area.

Separately, Commission Staff recently provided informal notice that it required Undine to submit its digital mapping data in a form different than the form Undine transmitted with the Application. Enclosed is the supplemental digital mapping data responsive to that request.

DECERTIFICATION AGREEMENT

Re: Application of Nerro Supply, LLC ("Nerro") and Undine Texas, LLC ("Undine") for Sale, Transfer or Merger of a Retail Public Utility in Brazos, Burleson, Chambers, Robertson, Montgomery and Walker Counties (Docket No. 49380)

Dear Deanville Water Supply Corporation District Representative:

On March 27, 2019, Nerro and Undine submitted an application to the Public Utility Commission of Texas ("PUC") for the sale, transfer or merger of a retail public utility and certificate rights from Nerro to Undine (the "Application"). Based on our review, the Application includes an area of overlap with Deanville Water Supply Corporation's ("Deanville WSC") CCN No. 10177. The attached map specifies the area of overlap.

This letter requests that Deanville WSC agree to decertification of the area identified on the attached maps for its CCN 10177 so that Nerro and Undine may incorporate those areas into the service areas that are otherwise the subject of the Application. We note that Deanville WSC does not now, nor has it ever, supplied drinking water service to customers within the area highlighted on the attached maps. Undine and Nerro seek Deanville WSC's decertification of the area for no compensation under Texas Water Code §13.254.

If approved, the decertification will allow Undine to exercise its authority to provide retail, public water and sewer utility service under Undine's STM Application to the portion of Deanville WSC's CCN No. 10177 requested for decertification.

If you agree to decertification of the identified area pursuant to the terms of this letter, please so indicate by signing in the area indicated below. We appreciate your consideration in this matter.


