## COMMISSION STAFF'S REQUEST FOR EXTENSION OF TIME

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Staff's Request for Extension, and would show the following:

#### I. BACKGROUND

On March 27, 2019, Nerro Supply, LLC (Nerro) and Undine Texas Environmental, LLC (Undine) (collectively, Applicants) filed an application for Sale, Transfer, or Merger of Facilities and Certificate Rights in Brazos, Burleson, Chambers, Montgomery, Robertson, and Walker Counties, Texas. Specifically, the applicants seek to sell and transfer portions of Nerro's facilities and service area under water Certificate of Convenience and Necessity (CCN) No. 12252 to Undine's CCN No. 13260. The requested transfer includes approximately 1,904 acres and 1,321 current customers. In addition to this sale and transfer, Undine requests to add approximately 369 acres in Burleson and Montgomery Counties to Nerro's CCN, and decertify approximately 85 acres in Burleson County from Nerro's CCN.

On June 23, 2019, Order No. 3 was issued establishing a deadline of August 8, 2019 for Staff to request a hearing or file a recommendation on the approval of the sale. Therefore, this pleading is timely filed.

#### II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Because Staff requires additional time to formulate its

recommendation on final disposition, Staff respectfully requests that the ALJ extend the deadline for filing of Staff's recommendation on final disposition to August 20, 2019. Staff notes that the 120-day deadline for the Commission to request or a hearing or approve the sale is October 7, 2019.

### III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request
