REQUEST FOR WAIVER

Undine Texas Environmental, LLC (“Undine”) hereby files a Request for Waiver requesting that the requirement that notice of this application be provided in a newspaper of general circulation be waived.

I. DISCUSSION

Commission Staff’s Supplemental Recommendation on Administrative Completeness and Proposed Procedural Schedule (Docket No. 49382-21) (“Supplemental Recommendation”) recommends that the applicants be ordered to provide two forms of notice: (1) direct notice to four categories of individuals/entities; and (2) “publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Chambers, Harris, and Walker Counties” (“Published Notice”). See PUC Interoffice Memorandum from P. Garcia to R. Tawater, attached to Supplemental Recommendation. Order No. 4 (Docket No. 49380-22), issued on July 18, 2019 adopted the Commission Staff’s recommendation, including a requirement that the applicants provide proof that notice was published in a newspaper of general circulation by August 19, 2019.

Undine requests that the requirement for Published Notice be waived. Undine identifies several factors in support of its request. First, the applicants are not proposing any change in CCN areas pursuant to this application. Second, the applicants are not requesting (and will not


experience) any changes to customer rates, tariffs or services as a result of the transaction that is the subject of the application. Third, any minimal benefit that could be derived from the Published Notice is substantially outweighed by the substantial expense the applicants (and rate payers) would incur in conducting the Published Notice (in excess of \$10,000). Finally, Undine notes the PUC has determined in similar circumstances that direct notice is sufficient. *See, e.g.,* Docket No. 49364.

II. CONCLUSION

THEREFORE, Undine hereby requests that its request for waiver of a requirement that notice be provided in a newspaper of general circulation be granted.
