FINDING CLOSING DOCUMENTATION SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the application, filed on March 27, 2019, for the sale, transfer, or merger of SWWC Utilities, Inc. dba Inverness to Monarch Utilities I, L.P. (applicants) in Travis County. The applicants seek approval to transfer all of SWWC's facilities and service area under water certificate of convenience and necessity (CCN) number 11170 to Monarch, amend Monarch's CCN number 12983 accordingly, and cancel SWWC's CCN number 11170. The applicants filed closing documents on December 18, 2019, and January 9, 2020.

The administrative law judge finds the closing documentation sufficient. However, the transfer of certificate rights requested in this application is not complete until the application receives final approval.

The following procedural schedule applies for continued processing:
