**JOINT STATUS UPDATE**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), SWWC Utilities, Inc. dba Inverness Utility Company, Inc., and Monarch Utilities I L.P. (collectively, the Parties), representing the public interest and files this Status Update in Response to Order No. 10. In support thereof, the Parties show the following:

On March 27, 2019, SWWC Utilities, Inc. dba Inverness Utility Company, Inc. and Monarch Utilities I L.P. filed an application for Sale, Transfer, or Merger of Facilities and Certificate Rights in Travis County, Texas. Specifically, the Applicants seek to transfer all of Inverness’s assets and water service area under certificate of convenience and necessity (CCN) number 11107 to Monarch Utilities’ CCN number 12983.

On April 2, 2020, the Parties filed a Joint Motion to Abate based on issues contained in Commission Docket No. 49732. The Parties Joint Motion to Abate was granted by the Administrative Law Judge (ALJ) in Order No. 10. The ALJ also required the Parties to file a Joint Status Report at the beginning of each quarter starting July 1, 2020, during the pendency of Docket No. 49732. This pleading is timely filed.

The Parties are still awaiting a resolution of Docket No. 49732 and Monarch Utilities and Commission Staff have both filed briefs as required by the Commission’s Order Requesting Briefing in Docket No. 49732.
