## JOINT MOTION TO UNABATE

The Staff of the Public Utility Commission of Texas (Staff) and Monarch Utilities I L.P. (Monarch) (collectively, the Parties) file this Joint Motion to Unabate the proceedings in this docket. In support thereof, the Parties show the following:

#### I. BACKGROUND

On March 27, 2019, Inverness and Monarch (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Travis County, Texas. Specifically, Inverness seeks to transfer all of its facilities and service area under water Certificate of Convenience and Necessity (CCN) No. 11170 to Monarch, and to cancel its CCN. The service area to be transferred includes 325 acres and 177 current customers. Applicants are affiliated entities that share the same parent company, SouthWest Water Company, Order No. 10, filed April 6, 2020, abated this proceeding until a resolution was reached in Docket No. 49732.

#### II. JOINT MOTION TO UNABATE

An order was issued in Docket No. 49732 on January 29, 2021. On March 5, 2021, the Administrative Law Judge (ALJ) issued Order No. 11 in this docket, requiring the parties to file a request that this docket be unabated along with a proposed notice of approval and final tariff, or propose a future date at which they will file a proposed notice of approval and final tariff. Therefore, the Parties respectfully request that this docket be unabated so that the case may move to final resolution. The Parties propose the following procedural schedule:
