("Coats Rose") represents Las Lomas Municipal Utility District No. 4A of Kaufman County, formerly known as Las Lomas Municipal Utility District No. 4 of Kaufman County ("Las Lomas 4A"), and Las Lomas Municipal Utility District No. 4B of Kaufman County ("Las Lomas 4B" and, together with Las Lomas 4A, the "Applicants"), in Public Utility Commission of Texas (the "Commission") Docket No. 49386.


