AFFIDAVIT OF CURTIS HUTCHESON

BEFORE ME, the undersigned authority, on this day personally appeared Curtis Hutcheson, who being by me first duly sworn, on oath, deposed and said the following:

- 1. My name is Curtis Hutcheson. I am of sound mind and capable of making this Affidavit. The facts stated herein are correct based on my personal knowledge.
- 2. I am employed by El Paso Electric Company ("EPE") as Supervisor-Regulatory Case Management. I have personal knowledge of the facts set forth in this Affidavit and am authorized to make this Affidavit on behalf of EPE.
- On March 28, 2019, EPE filed with the Public Utility Commission of Texas ("PUC" or "Commission") the Application of El Paso Electric Company for Approval of a Distribution Cost Recovery Factor ("DCRF Application") in PUC Docket No. 49395.
- 4. EPE simultaneously filed the DCRF Application with the cities that retain jurisdiction over EPE's rates consistent with the provisions of PURA and 16 Tex. Admin. Code § 25.243(c)(l)(A) ("TAC").
- 5. On March 29, 2019, EPE also provided notice via USPS Priority Mail to all parties of record in EPE's last comprehensive base-rate proceeding, Docket No. 46831, Application of El Paso Electric Company to Change Rates. EPE provided a copy of the DCRF Application, including attachments, to those parties. Pursuant to 16 TAC § 25.243(e)(2), the notice provided to the parties included the docket number for the new proceeding.
- 6. Because EPE has not previously filed a DCRF Application, the 16 TAC 25.243(e)(2) requirement to provide notice to parties in the utility's last DCRF proceeding does not apply.
