**CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC PRIVILEGE LOG TO
GULF COAST COALITION OF CITIES' THIRD REQUEST FOR INFORMATION**

On May 7, 2019, CenterPoint Energy Houston Electric, LLC ("CenterPoint Houston" or the "Company") filed objections to the Third Request for Information ("RFI") propounded by the Gulf Coast Coalition of Cities ("GCCC"). CenterPoint Houston objects to GCCC 3-3 and 3-12 to the extent that any documents responsive to the requests are protected from discovery due to the work product or attorney-client privileges.¹ Commission Procedural Rule 22.144(d)(2) directs CenterPoint Houston to file an index of privileged documents within two working days of filing an objection based on privilege. Although CenterPoint Houston has not identified any privileged documents at this time, it continues to exercise due diligence in compiling a response to these RFI requests, which are due May 13, 2019. If CenterPoint Houston identifies any privileged documents as it prepares its responses, it will supplement the index of privileged documents attached as Exhibit A.


