



### II. Standing to Intervene

On April 5, 2019, CenterPoint Energy Houston Electric, LLC ("CenterPoint") filed an application requesting authority to change rates. The Administrative Law Judge in Order No. 2 established May 20, 2019 as the intervention deadline, and therefore, this motion is timely.

Olin owns and operates chlor alkali manufacturing facilities at the Freeport Industrial Park in Freeport, Texas. Olin is directly impacted by this proceeding as a ratepayer. Olin pays CenterPoint's rates and ERCOT's Transmission Cost of Service ("TCOS") through Transmission

Cost Recovery Factors ("TCRFs") charged by Transmission and Distribution Service Providers ("TDSPs"). Olin is a ratepayer of CenterPoint, and will be directly impacted by any rate determination the Commission makes in this proceeding. Therefore, Olin has a justiciable interest that may be adversely affected by the outcome of this proceeding.

### IV. Conclusion and Prayer

Olin respectfully requests that the Commission grant this Motion to Intervene, admitting Olin as an Intervenor in this proceeding for all purposes. Additionally, Olin requests such other relief to which it may be entitled.
