ANSWER:

The Texas Franchise Tax Return due May 15, 2019 has not been filed. CenterPoint Energy, Inc. has filed an extension for this return which extends the due date until August 15, 2019. CenterPoint Energy Inc. also intends to file a second extension on or before August 15, 2019 extending the return until November 15, 2019.
