
I have reviewed the information produced by the Company in its updated response to the Office of Public Utility Counsel ("OPUC") request for information (RFI) OPC03-09 sufficiently to state in good faith that certain information contained in the Company's response is exempt from public disclosure under the Texas Public Information Act ("TPIA").¹

Certain materials contained in the Company's response to the RFI identified above contain information related to outside counsel for energy service providers that is commercially sensitive. The public disclosure of this information could cause substantial competitive harm to CenterPoint Houston and the persons from whom the information is obtained. Accordingly, certain designated materials contained in the Company's response to the RFI identified above is protected under Tex. Gov't Code §§ 552.101, 552.104 and 552.110 and Tex. Util. Code § 39.001(b)(4) and merits the Protected Materials (Confidential) designation it is given in CenterPoint Houston's response.
