FIRST SET OF REQUESTS FOR INFORMATION**


On June 3, 2019 CenterPoint Energy Houston Electric, LLC ("CenterPoint Houston") filed objections to the first set of Requests for Information ("RFIs") filed by H-E-B, LP ("H-E-B"). CenterPoint Houston specifically objected to RFIs H-E-B 1-3 and H-E-B 1-4. After continuing to negotiate in good faith, counsel for CenterPoint Houston and H-E-B reached an agreement to modify the scope of the RFI and to extend the deadline for CenterPoint Houston's response to June 14, 2019. Accordingly, CenterPoint Houston will respond to H-E-B 1-3 and H-E-B 1-4 consistent with the agreement to modify the scope of the RFIs and hereby withdraws its objections.


