



#### **LED Lighting**

Please refer to the Company's response to COH 02-11. With respect to the LED replacements from 2015-2018, what was the average length of time that an LED lighting installation had been in service before a replacement became necessary?

#### ANSWER:

Of the more than 200,000 LED luminaires that CenterPoint Houston has installed since 2015, fewer than 600 have failed. Given the minimal number of failures to date, the average length of time an LED installation was in service before a replacement became necessary has not yet been calculated.
