In the interest of facilitating the number-running phase of this proceeding (during which communications between number running Staff and the Company will be restricted), please provide a comprehensive explanation of the process the Company follows to tie its wholesale TCOS, retail cost of service, and ERCOT transmission payments when its TCOS is adjusted (some share of which changes the Company's ERCOT transmission payments and also impacts functionalization). Please provide workpapers supporting the Company's response.

5. Specific Instructions - Hardcoded Numbers

Certain numbers must be hardcoded to avoid circular references or other linking problems. If numbers are modified the user must make sure the following cells are manually updated in this order.

- 1) In <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "II-F Func Factors Data", update FF# 8 "Total O&M and A&G, excluding Fuel & Purchased Power [1]" by copying the numbers from Excel columns L through O and pasting as values in Column Nos. 1 through 4. Repeat this iteration until the variance columns are zero.
- 2) In <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "II-F Func Factors Data", update FF# 6 "Total Revenue Requirement [1]" by copying the numbers from Excel columns L through O and pasting as values in Column Nos. 1 through 4. Repeat this iteration until the variance columns are zero.
- 3) In <u>CEHE RFP Workpapers Errata 1.xlsx</u>, worksheet "WP II-F Func Factors", update FF# 8 "Total O&M and A&G, excluding Fuel & Purchased Power [1]" by copying the percentages from <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "II-F Func Factors", FF# 8 "Total O&M and A&G, excluding Fuel & Purchased Power [1]" in Column Nos. 1 through 4. Copy and paste as values into Excel columns E through H.
- 4) In <u>CEHE RFP Workpapers Errata 1.xlsx</u>, worksheet "WP II-F Func Factors", update FF# 12 "Personnel-related" by copying the percentages from <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "II-F Func Factors", FF# 12 "Personnel-related" in Column Nos. 1 through 4. Copy and paste as values into Excel columns E through H.
- 5) In <u>CEHE RFP Workpapers Errata 1.xlsx</u>, worksheet "TCOS Calculation", update cell M18 by copying the value from <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "III-A-1", Column No. 4, Line No. 12 "TOTAL ADJUSTED REVENUE REQUIREMENT' (cell G24). Copy and paste as values into cell M18.
- 6) In <u>CEHE RFP Workpapers Errata 1.xlsx</u>, worksheet "WP II-B-9", update cell B26 by copying the value from <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "I-A-1", Column No. 3, Line No. 6 "Return on Rate Base" (cell F17). Copy and paste as values into cell B26 and multiply by 1000 to get whole dollars.

- 7) In <u>CEHE RFP Workpapers Errata 1.xlsx</u>, worksheet "WP II-E-3.15" update cell F23 ("Pre-tax Income Per Books") by copying the value from <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "II-E-3.15", cell E28 (Line No. 14). Copy and paste as value into cell F23.
- 8) In <u>CEHE RFP Schedules Errata 1.xlsx</u>, worksheet "I-A", Column Nos. 1 and 2, Line Nos. 3 through 15 are pasted as values from <u>Schedule H-I-J and CA ERRATA 1.xlsx</u>, worksheet "WP I-A".

6. Specific Instructions - Class Allocation

- 1) If allocations are changed in <u>Schedule H-I-J and CA ERRATA 1.xlsx</u>, they impact worksheet "Schedule IV-J-1-Revenue Summary".
- 2) In order to flow through the change, you must determine which rate class is affected by reviewing "WP/ 1-A", Excel column I.
- 3) Once the rate class is determined, go to the corresponding "Schedule IV-J-7" worksheet for that rate class and insert the dollar value of the difference in the adder calculation column.
- 4) For the lighting classes, open the respective supporting workpaper (listed above) and links update automatically within the lighting supporting workpapers and in <u>Schedule H-I-J and CA ERRATA -</u> 1.xlsx.
