### CENTERPOINT ENERGY HOUSTON ELECTRIC LLC'S MOTION TO STRIKE ALL INTERVENORS WHO FAILED TO <u>FILE DIRECT TESTIMONY OR A STATEMENT OF POSITION</u>

CenterPoint Energy Houston Electric, LLC ("CenterPoint Houston") files this Motion to Strike All Intervenors Who Failed to File Direct Testimony or a Statement of Position. In support, CenterPoint Houston shows as follows:

In SOAH Order No. 6, the Administrative Law Judges stated that "Any party that filed neither direct testimony or a statement of position by the deadline is subject to being stricken as a party."<sup>1</sup> Consistent with SOAH Order No. 6 and in accordance with 16 Texas Administrative Code §§ 22.124 and 22.161, CenterPoint Houston requests that Olin Corporation be dismissed as a party for failure to file direct testimony or a statement of position and that this entity be prohibited from further participation in this case.
