ORDER NO. 1 FILING DESCRIPTION AND NOTICE OF PREHEARING CONFERENCE

Filing Description

On April 29, 2019, El Paso Electric Company (EPE) filed a petition seeking to implement an interim refund of net fuel cost over-recoveries. According to the petition, EPE is seeking authorization to refund \$19,219,730 of over-recovered costs and \$166,400 of interest, for a net total of \$19,386,130. This balance is made up of: (1) the principal of (\$385,742) and interest of (\$32,261) balances from Docket No. 46308; (2) the cumulative over-collection of fuel costs and interest from April 2016 through March 2019 of \$19,605,472 and \$96,359, respectively; and (3) interest for the period April 2019 through September 2019 of \$102,302. This total assumes that the Public Utility Commission of Texas (Commission) will authorize the fuel refund in time for implementation beginning with EPE's June 2019 billing cycle.

The Commission has jurisdiction over this proceeding pursuant to PURA §§ 14.001, 36.001, and 36.203.¹ The Commission referred this case to the State Office of Administrative Hearings (SOAH) on April 30, 2019, requesting the assignment of an Administrative Law Judge (ALJ) to conduct a hearing and issue a proposal for decision (PFD), if necessary. SOAH has jurisdiction over matters relating to the conduct of the hearing in these proceedings pursuant to Tex. Gov't Code § 2003.049.

Notice of Prehearing Conference

A prehearing conference will convene in this matter at 10:00 a.m. on May 16, 2019, at the SOAH hearing facilities located at the William P. Clements Office Building, 300 West 15th, Fourth Floor, Austin, Texas. The following matters will be discussed:

- 1. Any pending motions to intervene.
 - 2. An interim order to allow EPE to implement its proposed refund beginning with the June 2019 billing cycle.
 - 3. Any other motion filed by 3:00 p.m. on May 13, 2019.
 - 4. Proper notice of the proceeding.
 - 5. A procedural schedule.
 - 6. The protective order proposed by EPE.
 - 7. Any other matters that may assist in the disposition of this case in a fair and efficient manner.

Those attending the prehearing conference are advised that they must check in with building security personnel in the lobby of the William P. Clements Building and be issued visitor badges before proceeding to the hearing room. The parties should allow sufficient time for the check-in procedure.
