I. Agreed Procedural Schedule

SOAH Order No. 1 directed the parties to confer and submit a proposed procedural schedule by June 10, 2018. The parties have conferred and agreed to the following schedule:

Statements of Position; Objections to rebuttal/cross-rebuttal (replies to objections made live at hearing)	Tuesday, July 30, 2019
Hearing on the Merits	Friday, August 2, 2019

II. Motion to Cancel Prehearing Conference

SOAH Order No. 1 also directed parties to file a request to cancel the prehearing conference by Thursday, June 6, 2019 if there are no outstanding issues that need to be discussed. Parties agree that there are no outstanding issues to be taken up at a prehearing conference and request that the prehearing conference scheduled for Monday, June 10, 2019 be canceled.
