1. SUFFICIENCY OF APPLICATION AND NOTICE

Pursuant to Order No. 1, on June 7, 2019, Public Utility Commission staff (Staff) filed its Recommendation on Sufficiency of Application and Notice (Recommendation). After discussing the various components of Entergy Texas, Inc.'s (Entergy) Application to Adjust Its Energy Efficiency Cost Recovery Factor (Application), Staff recommends that Entergy Texas Inc.'s Application be deemed sufficient. The Administrative Law Judge has reviewed Staff's comments and concurs. Therefore, Entergy's Application to Adjust Its Energy Efficiency Cost Recovery Factor is hereby deemed **SUFFICIENT**.

Similarly, Staff also reviewed the Proof of Notice (Notice) filed by Entergy on May 15, 2019. Staff advises that Entergy's Notice satisfies the requirements of 16 Texas Administrative Code § 25.182(d)(13)-(14) and requests that Entergy's Notice be found sufficient. The ALJ concurs and Entergy's Notice is also deemed **SUFFICIENT**.


